# December 28, 2023 Town of Lyme Year End Meeting 3:00 P.M.

## Call to Order:

Supervisor Countryman called the meeting to order at 3:00 p.m. opening the meeting with the Pledge of Allegiance.

## Privilege of the Floor:

There was a special use permit submitted on December 15, 2023, by Terra Development Inc. (James Sheehan) for a limestone Quarry located at 18848 South Shore Road, Three Mile Bay, NY 13693 (70.00-1-17).

*Supervisor Countryman* explained that the Town has been inundated with phone calls and emails regarding the proposed Quarry on Point Peninsula.

There were several residents that spoke in opposition of the proposed Quarry Point Peninsula. Some concerns included that the Town Residents should have been notified sooner. Another concern was that the trucks traveling up and down the road will not only pollute the environment but cause unnecessary traffic up and down the quiet streets. Several residents were concerned that their wells would be disturbed, destruction of natural habitats of wildlife creatures, setbacks and barriers, hours of operations, adverse impact on quality of life, health, and safety risks.

The Town Board explained that the planning board can refuse the application or issue it with special permissions. It is going through the process. The Planning Board has the authority to issue the special use permit. It is allowed in our zoning in the agricultural district. They also explained that they understood the residents' concerns.

Joel Block stated that there are over 800 signatures for the petition against the quarry.

There was further discussion regarding the opposition of the quarry.

we only have the Highway Garage project in 2024, we will receive a project audit. This is strictly an accountant's suggestion. The Veteran's Park expenses will be over the cost of our DASNY grant therefore we will be using the ARPA funds for the remaining invoices.

Councilmember Villa explained that the cost increased because of the cost of materials and geothermal heating system. We will be able to apply for grants to reimburse us for the heating efficiency system. The original budget was from 2 years ago.
